• Welcome and introductions – Carol Tuning, CoC Chair

- Carol Tuning began the meeting at 9:00 a.m. with introductions by those in attendance.
- The overall scoring on the CoC application was 172.25 out of 200 points. The highest score in the country was 190.75. The lowest score was 57.75 and the weighted median was 159.75. All renewal applications were funded. The award announcement should be here in July.

• CoC Operating Guidelines

- The CoC Operating Guidelines are reviewed each year. Changes for this year are highlighted in the distributed copy. The guidelines will be voted on in the July meeting.
- Carol Tuning volunteered to be CoC Chair for the new year.
- Jeanne McCormack offered to be the CoC Vice Chair. Carol Tuning will confirm that Marie Muddiman does not want to continue as Vice Chair.
- It was recommended the Executive Committee make suggestions on the Standing Committees that need to be in place for the new year.
- All suggestions and feedback are due to Carol Tuning by July 10.

• Coordinated Entry Policies and Procedures

- There are three additions to the Coordinated Entry Policies and Procedures: Grievance Process (page 12) and the Appeal Form; Homeless Services Flowchart; the definition of Chronic Homelessness (page 8).

• Strategic Planning Discussion – Review and Update Goals

- There will be at-length discussions on youth homelessness during the Strategic Planning session.

• CoC System Performance Reports – Matt Crookshank

- Matt revised the report layout to reflect the standards communities have to meet to be designated as a high performing community.
- There are month-to-month, YTD and average comparisons listed. Matt will continue to work on reporting other performance measures in this format.

• BNL Committee Updates – Susan Trout/Marie Muddiman

- Veterans 25 active, 4 housed in May, Chronic Vets 9 active
- Chronic 23 active, 0 housed, 0 inactive
- Family 16 active, total of 57 housed in 2018
- Youth 17 active, 6 need to be added to list, 1 inactive, 2 housed in May
- Many CoC's are experiencing an increase in numbers also.
- Family Promise noted their increases are due to drug use and serious mental health issues. People are not being approved for mental health services like in the past, including unable to get medications.
- Rescue Mission is experiencing an increase in homeless sex offenders.

• Partner Agency Announcements

- Roanoke City has a part-time position open for Central Intake.
- Substance Abuse Program at VA.
- Rescue Mission has an opening for a mental health case manager at the Women's shelter.
- Kristin Moses is looking for an individual with Early Childhood experience.
- Turning Point is looking for a 3rd shift Housing Monitor.

- Summer PIT Count is scheduled for July 19 for sheltered and unsheltered individuals. The PIT count will give us a comparison between summer and winter data.
