ARCH Roanoke requests a renewal of our project for seven single units of permanent supportive housing for chronically homeless veterans in the Roanoke Valley. Trust House is requesting funding for leasing, as well as supportive services to include case management; food, transportation for participants, and mileage for staff to complete weekly home visits. ARCH currently serves 15 homeless veterans each night through our shelter program in collaboration with the Salem VA Medical Center and is an active participant in the CoC By Name List committee for homeless veterans. Referrals for this program will be garnered from both places. ARCH utilizes a Housing First approach that is low barrier for entry into the program so participants are not required to have income or length of sobriety to enter housing. For this reason, ARCH is requesting funding to cover 100% of housing costs that includes rent, deposits, and utilities. It is our hope that by removing these barriers, we will be able to house people quickly to aid in their stabilization. ARCH understands the barriers to mental health and substance abuse treatment for participants without health insurance and currently offers peer recovery support groups once a week to all participants of this project. It is ARCH's hope that these wrap around services will allow participants the tools needed to maintain their stability in the community. ARCH currently has a housing stability case manager who is SOAR certified. The CM provides harm reduction and trauma informed case management services to residents exiting homelessness, who are in need of support after entering permanent housing. ARCH utilizes two therapeutic modalities: Stages of Change and Person Centered Care to guide our work and encourage participants to live the best and healthiest life possible. Participants receive services in their home and in the community as needed. The case manager will work with community partners to make referrals, coordinate services and monitor progress. ARCH will work toward three main outcomes: participants will remain housed after two years; participants will maintain or increase their income; and participants will improve their self-sufficiency during their time in the program. ARCH has partnered with area landlords to provide the physical housing and property management. ARCH has also entered into a master lease with each landlord and sublease to all program participants, which also includes an agreement for maintaining services in alignment with Housing First principles.
